As of December 7, 2009

A **cellphone-free driving policy** is one that meets the basic criteria of the Coalition's generic policy:

- Company employees are not permitted to use a cellphone, either hand-held or hands-free, while operating a motor vehicle on company business and/or on company time.
- While driving, calls cannot be answered and must be directed to voicemail.
- If an employee must make an emergency call (911), the vehicle should be parked in a safe location before making the call.
- All employees will be made aware of the company policy and will be expected to comply with it.
